Colonoscopy	All Members	\$50.00	A colonoscopy is considered the gold standard to preventing Colorectal Cancer and typically completed every 10 years. Colonoscopies are recommended starting at the age of 45 until at least 75 years old. This reward is available to all Senior Care Plus members who receive a colonoscopy in 2025. This reward may not be combined with the FIT or Cologard screening reward. The first complete screening will be rewarded.	THIS SCREENING MAY NOT BE COMBINED WITH THE FIT/COLOGARD SCREENING TEST. FIT Test or Cologuard Test	All Members	\$10.00	A Fecal Immunoassay Test (FIT) is an alternative way to detect colorectal cancer and can be done from your home. This test is done annually and is recommended if you are not going to receive a colonoscopy. A cologard is another at home screening test and is done every three years. Colorectal Cancer screenings are recommended for all members ages 45-75. This reward is available to all Senior Care Plus members who complete a FIT or Cologard screening in 2025. This reward may not be combined with the colonoscopy screening reward. The first complete screening will be rewarded.	THIS SCREENING MAY NOT BE COMBINED WITH THE COLONOSCOPY SCREENING. Mammogram	All Members	\$15.00	Regular Mammograms can help detect breast cancer early, when it is easier to treat. This reward is available to all Senior Care Plus Members complete a mammogram in 2025. Ultrasounds of the breast are excluded.
